

GENAI SUPPLEMENTAL TERMS FOR ACCENTURE SOFTWARE FOR HCM AND ERP CLOUD TOOLS AS A SERVICE

As part of the SaaS Services, Authorized Users may be granted access, solely for the Permitted Purpose, to certain functionalities powered by Generative AI (the “GenAI Functionalities”) which may generate or return content to the Authorized User as a result of the Authorized User’s use of the GenAI Functionalities, including in response to queries or prompts that are submitted to the GenAI Functionalities by the Authorized Users (the “GenAI Output”). If so informed (or if Accenture otherwise believes so or becomes so aware at its own discretion), Accenture has the right to deactivate the GenAI Functionalities without penalty. Further, Accenture may cease the use of the GenAI Functionalities without penalty where Accenture reasonably believes the GenAI Functionality fails to meet its intended purpose in connection with the SaaS Services and the Permitted Purpose.
